### WHO CHOULD APPL

- Companies with a minimum of 51% black ownership operating and trading within the Gamagara / Ga-Segonyana / Tsantsabane Local Municipalities for 12 months or more.
- Companies supplying catering, cleaning and construction services.
- Companies with an annual turnover of less than R5O-million and classified as an EME or QSE as per the B-BBEE Codes of Good Practice.
- Although not a requirement, preference will be given to companies with a majority (51% or more) youth or female ownership.

   Ltd – Khumani Iron Ore. Kindly note that this does not include companies who are only registered as potential suppliers on the potential vendor portal and who have not yet supplied goods or services to Assmang (Pty)
   Ltd – Khumani Iron Ore.
- Companies with directors, founding members, or owners who have previously benefited from the Khumo Programme or any other Enterprise Development Programme sponsored by Assmang (Pty) Ltd – Khumani Iron Ore.
- Companies involved in liquor sales or possessing a liquor license.
- Companies operating illegally or who are engaged in any form of criminal activity.
